Business Challenges

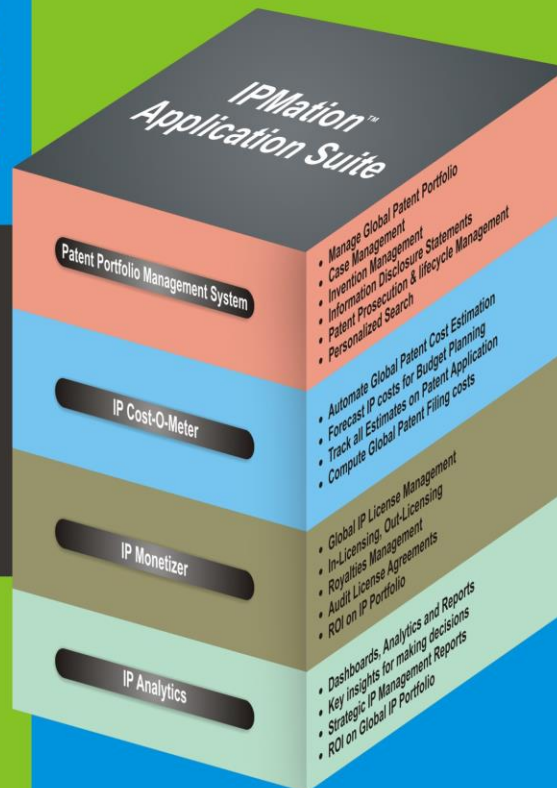
